प्रिय महोदय/महोदया,

हमें आपको यह बताते हुए खुशी हो रही है कि संस्थान 03-04 अगस्त, 2023 के दौरान सामाजिक सुरक्षा संहिता, 2020 पर एक प्रशिक्षण कार्यक्रम आयोजित करेगा।


कार्यक्रम का उद्देश्य प्रतिभागियों को सामाजिक सुरक्षा संहिता, 2020 की प्रमुख विशेषताओं की व्यापक समझ से लैस करना है। कार्यक्रम के मुख्य उद्देश्य कोड के तहत संगठित और असंगठित क्षेत्र के संदर्भ में विभिन्न सामाजिक सुरक्षा योजनाओं का विश्लेषण करना और सामाजिक सुरक्षा योजनाओं को समझना है। संहिता में किए गए सुधार/परिवर्तन और सुधार श्रमिकों के मुद्दों को कैसे संबोधित करेंगे और यह भी कि संहिता नियोक्ताओं को उनके व्यवसायों पर कैसे प्रभावित करेगी। नामांकन के तौर-तरीकों सहित प्रशिक्षण कार्यक्रम के सभी विवरण प्रदान करने वाला ब्रोशर संलग्न है।

कोई कार्यक्रम शुल्क नहीं है। संस्थान प्रशिक्षण अवधि के दौरान प्रतिभागियों को निःशुल्क रहने और खाने की सुविधा प्रदान करेगा। तथापि, यात्रा व्यय प्रायोजक संस्था द्वारा वहन किया जाएगा। संस्थान केवल सेंट्रल ट्रेड यूनियन लीडर्स के प्रतिभागियों को स्लीपर ट्रेन के द्वितीय श्रेणी के किराए की प्रतिपूर्ति करेगा। यह प्रशिक्षण कार्यक्रम विशेष रूप से केंद्रीय और राज्य श्रम विभागों के सरकारी अधिकारियों और केंद्रीय ट्रेड यूनियनों के लिए तैयार किया गया है, जो कम से कम पांच साल के कार्य अनुभव और अंग्रेजी और हिंदी दोनों के ज्ञान के साथ 60 वर्ष से कम आयु के हैं।

हम आपसे अपने विभाग से 05 अधिकारियों को मनोनीत करने का अनुरोध करते हैं। सीटों की सीमित संख्या के कारण, संस्थान पहले आओ-पहले पाओ के आधार पर एक संगठन से केवल 05 प्रतिभागियों को प्रवेश देने के लिए विवश होगा और उसके बाद खेद स्वीकार करेगा। हम महिला अधिकारियों की भागीदारी की अत्यधिक सराहना करेंगे। आप कृपया नामांकित व्यक्तियों द्वारा विधिवत भरे गए नामांकन प्रपत्रों के साथ प्रतिभागियों के नाम अग्रेषित करें। नामांकन प्राप्त करने की अंतिम तिथि 13 जुलाई, 2023 है।

The programme will commence on August 03, 2023 at 09:00 a.m. and conclude on the August 04, 2023 after lunch. The classes will be held from 9:00 am to 05:00 pm.

The Institute campus is situated near Prakash Hospital and NTPC Office. The distance of the campus from New Delhi Railway Station is 20 Kms and 1.5 Kms from Metro Railway Station, Noida City Centre.

STAY ARRANGEMENT

Stay arrangement will be made in the hostel of V.V. Giri National Labour Institute. The boarding and lodging will be provided by the Institute from the afternoon of August 02, 2023 till the forenoon of August 05, 2023. For extended stay or early arrival, lodging & boarding charges would be borne by the participants. The travel charges of the participants will be borne by the sponsoring organisation.

TRAVELLING EXPENSES

1. No fee is charged from the participants.
2. The Institute would reimburse travel expenses of the participants for 2nd class sleeper Train/Bus fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of ticket should be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconveniences.
3. It may be ensured that nominee(s) should have Aadhar number. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. All the nominees may be informed accordingly.
4. The local conveyance will be reimbursed restricted to the actual expenditure incurred or Rs. 500/- whichever is less (Rs. 350/- for Delhi & NCR).
5. The Institute would reimburse travel expenses of the North Eastern participants for 3 tier AC Train fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of 3rd AC ticket shall be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconvenience. The local conveyance to be reimbursed would be restricted to the actual expenditure incurred or Rs. 750/- whichever is less.
6. Officials entitled for higher class may claim their Travelling Allowance from their own organization.
7. The participants are provided free of cost boarding and lodging only for the duration of the programme.

PROGRAMME FEE

There will be no fee for the programme.
