INTRODUCTION

Labour law also known as employment law is the body of laws and administrative rulings which address the legal rights of, and restrictions on, working people and their organisations. It mediates many aspects of the relationship between trade unions, employers and employees. Generally labour law covers – industrial relations, workplace safety and health employment standards such as working hours, wages, layoff procedures, etc.

The knowledge of labour laws empowers both the executives as well as employees. Keeping this in view, the V.V.Giri National Labour Institute is conducting the programme on Labour Laws for Executives & Trade Union Leaders. Since it is not possible to cover all the labour laws during the programme, only the select labour laws would be covered having the following aim and objectives.

AIM

The programme aims at equipping the participants with the context of labour legislation and recent Labour jurisprudence.

OBJECTIVES

- Employment standards including holidays, leave, working hours, dismiseals, wages, layoff procedures.
- Industrial relations certification of unions, labour management relations collective bargaining and unfair labour practices.
- Workplace safety and health standard
- New Labour Codes code on wages, 2019 and Rules; Code on Industrial Relations, 2020 and Rules
- Code on Social Security, 2020 and Rules
- Code on Occupational Safety, Health and Working Conditions, 2020 and Rules.
