- 2. Should be personally engaged at grass root level activities for at least past two years;
- 3. Should be fluent in either Hindi or English.

- 2. Spouse and family members are not allowed to stay in the Institute's hostel.
- 3. Participants are requested to book their return ticket in advance from their own place.
- 4. Under no-circumstance other than IInd class sleeper train fare will be entertained.

STAY ARRANGEMENT

Stay arrangement will be made in the hostel of V.V. Giri National Labour Institute. The boarding and lodging will be provided by the Institute from the afternoon of July 03, 2022 till the forenoon of July 09, 2022. Accommodation will be on twin-sharing basis. For extended stay or early arrival, lodging & boarding charges would be borne by the participants.
