AIM

To build the knowledge, skills, and attitudes of stakeholders to design, implement, and monitor social protection measures that are inclusive, gender-sensitive, and responsive to the unique vulnerabilities of migrant workers, ensuring their equitable access to rights, entitlements, and decent work conditions.

OBJECTIVES

- 1. **Knowledge & Understanding** (i) understand the linkages between gender, migration, and social protection, (ii) discuss international labour standards, CEDAW, GCM, SDGs, and their relevance for migrant workers' social protection, (iii) review India's social protection framework (labour codes, e-Shram, ESIC, state schemes, bilateral agreements) with a gender lens.
- 2. Evidence & Analysis (i) familiarise participants with current data sources and evidence on migrant workers (e.g., PLFS, NSSO, Census, e-Shram, ILO databases), (ii)train participants in using gender-disaggregated data for evaluating policy impacts, (iii) expose participants to case studies showing successes and limitations in gender-responsive social protection for migrants.
- 3. **Skills & Application** (i) develop capacity to conduct gender-responsive needs assessments for migrant workers, (ii) build skills in designing inclusive social protection interventions, integrating gender and migration, (iii) train participants in monitoring & evaluation (M&E) tools that incorporate gender-responsive indicators.
- 4. **Policy & Practice** (i) enable participants to identify barriers migrant women face in accessing social protection (documentation, portability, awareness, discrimination), (ii)explore strategies for mainstreaming gender in labour policies, (iii) strengthen understanding of coordination between government, state welfare boards, employers, trade unions, and NGOs in delivering GRSP.
- 5. Outcomes & Leadership (i) empower participants to translate evidence into advocacy and programme recommendations, (ii) encourage participants to prepare action plans that they can take back to their organisations, states, or sectors.

COURSE PROFILE

Understanding of gender dimensions of the migration and social protection, develop capacity for monitoring & evaluation (M&E) tools that incorporate gender-responsive indicators, empower participants to translate evidence into advocacy and programme recommendations

PARTICIPATION LEVEL

- Labour Department officials
- Researchers / academics with experience of working on gender and migrant workers
- Senior Representatives of Central Trade Unions (at least 10 years experience)

ELIGIBILITY

- 1. Participants should be above 25 years and below 50 years of age.
- 2. Should be fluent in English and Hindi.

NOTE:

- 1. Please note that those who have already attended Institute's earlier programme are not to be nominated. If so, they shall be immediately sent back and no travel allowance will be reimbursed.
- 2. Spouse and family members are not allowed to stay in the Institute's hostel.
- 3. Participants are requested to book their return journey ticket in advance from their own place.

VENUE

V. V. Giri National Labour Institute Sector –24, NOIDA –201301,

The Institute campus is situated near Prakash Hospital and NTPC Office. The distance of the campus from New Delhi Railway Station is 20 Kms. Delhi Metro, Noida City Centre Station is about 1.5 kms from VVGNLI, Noida.

FEES & TRAVELLING REIMBURSEMENT

There is no programme fee.

- 1. The institute will reimburse travel expenses by bank transfer; for participants who have an Aadhaar number and a bank account. It's important for nominees to bring their bank details (bank name, branch, IFSC code, and account number) to fill up the TA form. Participants must attach the original ticket for the inward and outward journey. Without proper tickets, no claims will be re-imbursed.
- 2. The institute will reimburse 2nd class sleeper (Non-AC) train or bus fare (Non-AC) from their place to VVGNLI (NOIDA) and back. Local conveyance at the maximum of ₹350 for (Delhi & NCR) and ₹500 (for other states except North East States).
- 3. For participants from the North Eastern States, the Institute will reimburse 3-tier AC train fare and local conveyance, subject to a maximum limit of ₹750. In case a participant does not possess a 3-tier (AC) return ticket, reimbursement will be made for II sleeper class fare only, however the difference of 3-tier (AC) train fare shall be paid only upon submission 3-tier (AC) return ticket.
- **4.** Officials entitled for higher class may claim their Travelling Allowance from their own organisation.
- **5.** For extended stay or early arrival, lodging & boarding charges would be borne by the participants.
