#### FROM THE DIRECTOR GENERAL'S DESK

#### Transforming Employment in India: A Decade of Progress

Employment is a cornerstone of economic growth, social stability, and individual prosperity. Over the past decade, India has made significant strides in employment through strategic government policies and initiatives. The country has embraced transformative changes that have positively impacted the labour market, fostering job creation and reducing unemployment.

India's demographic dividend, characterised by a large youth population, presents a unique opportunity for economic advancement. This youthful workforce drives innovation, productivity, and economic prosperity. Harnessing this advantage through investments in education, skill development, and job creation is crucial for realising India's aspirations for sustainable development.

The National Statistical Office (NSO) provides insights into India's employment landscape through the Periodic Labour Force Survey (PLFS). Since its inception in 2017, the PLFS has been aiding policymakers in formulating strategies aligned with the evolving needs of the labour market. The data from PLFS indicates that the Labour Force Participation Rate (LFPR) has shown an encouraging trend, with increases observed in both rural and urban areas. This rise, particularly in rural areas, can be attributed to improved job opportunities, increased access to education and training, and changing social attitudes towards women working outside the home. The participation of females in the labour force has notably increased, reflecting a positive shift towards gender equality in employment.

The employment rate has significantly improved, especially in rural areas. The rise in female employment rates has been remarkable, driven by factors such as increased investment in rural infrastructure and effective government policies aimed at employment generation and poverty reduction. In urban areas, the overall employment rate has also increased, with a notable rise in female employment, indicating better participation of women in the workforce.

The unemployment rate in India has consistently declined, from 6.0 percent in 2017-18 to 3.2 percent in 2022-23. This reduction is particularly significant in rural areas, where the rate fell from 5.3 percent to 2.4 percent. The decline in female unemployment rates further highlights the progress in improving employment opportunities for women.

Regular salaried employment has shown a positive trend, with the number of regular salaried persons increasing from 104.1 million in 2017-18 to 118.6 million in 2022-23. The government's efforts during the COVID-19 pandemic facilitated a rebound in regular salaried employment, reflecting the effectiveness of measures such as the ABRY and the MGNREGS in addressing job market challenges.

The entrepreneurial landscape in India has also seen a positive shift, with a significant increase in the number of self-employed individuals who provide jobs to others. Government initiatives like PMMY, Start-up India, and Stand-up India have been instrumental in promoting entrepreneurship, contributing to job creation and economic growth.

The decline in the NEET (Neither in Employment, Education, nor Training) population is another positive indicator of progress. Government initiatives aimed at enhancing vocational training, improving access to education, and facilitating employment opportunities have helped reduce the NEET rate, empowering more young people to engage in productive activities.

Government schemes and programmes have yielded positive results, with the employed population increasing from 455.3 million in 2017-18 to 567.9 million in 2022-23. The number of unemployed individuals has significantly decreased from 29.0 million to 18.5 million, showcasing the effectiveness of these initiatives in addressing economic challenges.

To summarise, India's employment landscape has undergone significant transformation over the past decade. The government's strategic policies and initiatives have played a crucial role in job creation, reducing unemployment, and fostering a dynamic labour market. As India continues to harness its demographic dividend, sustained efforts in education, skill development, and entrepreneurship will be key to achieving long-term economic growth and prosperity.

#### Labour Force Participation: Measuring the Global Gender Gap Trends NLI Research Studies Series No. 159/2023

The Indian constitution provides equal rights and benefits to men and women, as well as parallel procurement to raise the status of women in society, the rights and opportunities provided to women by the constitution are still far from being fully utilised by the majority of women. "The antifemale attitude and inequalities in society force women to revert to conventional value systems, such as taking on too much home responsibilities, which limits their ability to thrive. In the modern period, a number of other concerns, such as low literacy, unemployment, and poverty among women, are all too widespread in India due to societal gender disparities".

The present study intends to contribute to the evaluation of policy and regulation efficacy at the national and international level, taking into account current welfare regimes and corresponding labour market disparities. It could enable in assisting the policymakers in comprehending the

implications of gender disparities for framing affirmative assertive trickledown impact on the stakeholders.

#### Orientation programme on Responsible Business Practices (January 16-19, 2024)




#### **COLLABORATIVE TRAINING PROGRAMME (CTP)**


#### Effective Conciliation for Dispute Resolution (January 08-09, 2024)
