#### **CONTEXT**

Migration plays a significant role in today's world. Understanding the intricacies of gender and migration can result in programs and policies that enhances and decrease the cost for female migrants. For such an understanding to be developed, analysts and experts need reliable and accurate data and in-depth gender analysis in migration studies.

#### **Types of Migration are:**

**Internal Migration** - Moving within a state, country or continent.

**External Migration** – Moving to a different state, country, or continent.

**Emigration** – Leaving one country to move to another.

**Seasonal Migration:** Moving with each season or in response to labour or climate conditions.

Women are increasingly migrating on their own, often to enhance economic opportunities by seeking jobs or education. Data indicate that the rate of female migration is growing faster than male migrants in many countries that receive high levels of migrants. This trend is commonly referred to as "feminization of migration"

The International Labour Organization estimates that women are half of the global migrant population but in some countries account for 70-80 percent of migrants (Third edition of the Global Estimates on International Migrant Workers, 2018).

Migration can improve autonomy, human capital, and self-esteem, as well as women's authority and worth in their families and community. Migration can change traditional norms as women gain access to education and economic opportunities. The introduction to more equitable social norms can also improve women's rights and access to resources. When migrant women return home, they often maintain their newfound autonomy and bring new norms, skills, and expertise, with this new skills returning migrant women often start their own business.

Although migration is largely beneficial, many constraints- such as restrictive social norms or laws, gender or racial discrimination, or gender-specific vulnerabilities- limit the opportunities and benefits. Migrants may suffer to have their professional credentials, language, race or culture barriers and discrimination. Legal restrictions

impede migration for women more than men.

In some countries, women's employment and mobility from their homes, communities, or countries is legally restricted.

Migrant women's human rights must be protected, and migrants must have access to services and resources, such as health, legal, financial services etc. Officials and recruitment agencies must be regulated, monitored, and trained on gender sensitivities and human rights, similarly, the public can be better informed and educated about the benefits, consequences, and contribution of migration, thereby decreasing xenophobia and discrimination.

Conducting more research and collecting sex-disaggregated data will be addressing knowledge gaps and providing a more complete analysis of gender and migration. Ultimately better research and understanding will support improved programmes and policies, help the benefits of migration to be realised, and enhance the agency of migrants while reducing the risks and vulnerabilities they face.

In this backdrop, Centre for Rural Development and Management, Bangalore University&Centre for Agrarian Relations, Rural and Behavioural Studies, V.V. Giri National Labour Institute, Noida are organising online training course "MIGRATION OF RURAL LABOUR IN INDIA- A CASE OF WOMEN MIGRANTSIN KARNATAKA" during 26-29 July, 2022.
