AIM

The programme aims at enhancing the understanding of the participants on the process of labour reforms in India. It would orient the participants to have an understanding on the key features of various labour codes.

OBJECTIVES

- To discuss the overall framework of labour legislation in India and the context of labour law reforms:
- To provide an overview of the constitutional framework for formulation of labour legislation;
- To discuss the key features of four labour codes and rules;
- To understand the implication of these codes on the labour market.

COURSE PROFILE

Framework of Labour Legislation, Constitutional Provisions, the Code on Wages, Code on Industrial Relations, Occupational Safety, Health and Working Conditions Code and Social Security Code and Draft Central Rules.

RESOURCE PERSONS

Faculty members of VVGNLI and expert(s) associated with drafting of labour codes and senior labour administrator will be the key resource persons.

PARTICIPATION LEVEL

Government Officials, Labour Officials and Trade Union Leaders. Further, as this is an online training, those enrolling in the programme should have access to internet and laptop/desktop with audio-visual facilities.

TRAINING DELIVERY AND METHODOLOGY

This training will be delivered in an online mode. The training will primarily make use of lectures and discussions, followed by questions and answers. Each session will be based on a structured Power Point Presentation.

This programme is scheduled from November 08-10, 2021. Online sessions will be held from 10:30 pm to 04:30 pm.
