सहर्ष सूचित किया जाता है कि वी. वी. गिरि राष्ट्रीय श्रम संस्थान अपने परिसर में अप्रैल 26-28, 2022 के दौरान बाल श्रम और बंधुआ मजदूरी के रोकथाम और उन्मूलन पर संवेदीकरण विषय पर एक प्रशिक्षण कार्यक्रम आयोजित करने जा रहा है।

कार्यक्रम को विशेष रूप से ट्रेड यूनियनों, नागरिक समाज संगठनों, पंचायती राज संस्थानों (पीआरआई) के निर्वाचित प्रतिनिधियों और चाइल्ड लाइन के लिए तैयार किया गया है। कार्यक्रम का उद्देश्य बाल श्रम और बंधुआ मजदूरी के मुद्दों को प्रभावी ढंग से संबोधित करने के लिए हितधारकों और सामाजिक भागीदारों के बीच अनुभवों को साझा करना और अभिसरण को मजबूत करना है। कार्यक्रम का विवरण संलग्न है।

यह एक निःशुल्क कार्यक्रम है। संस्थान प्रशिक्षण अवधि के दौरान प्रतिभागियों को आवास एवं भोजन निःशुल्क उपलब्ध करेगा, तथा टिकट की प्रति मिलने पर द्वितीय श्रेणी के स्लीपर रेल किराए की प्रतिपूर्ति भी करेगा। यह सुनिश्चित किया जाए कि केवल उन्हीं प्रतिभागियों को नामांकित करें जिन प्रतिभागियों के पास आधार कार्ड है। प्रतिभागियों के लिए यात्रा किराया की प्रतिपूर्ति केवल एनईएफटी के माध्यम से किया जाएगा। प्रतिभागियों को उनके आधार नंबर एवं बैंक विवरण (बैंक का नाम, बैंक शाखा, बैंक खाता संख्या, आईएफएससी कोड) साथ लाने का निर्देश दिया जाना चाहिए। प्रतिभागियों को आधार नंबर एवं बैंक विवरण टीए फार्म भरने के समय देना आवश्यक है।

आपसे अनुरोध है कि अपने एनसीएलपी जिले से 03 प्रतिभागियों को नामित करें। महिलाओं का नामांकन अत्यंत सराहनीय होगा। सीटों की संख्या सीमित होने के कारण संस्थान पहले आओ-पहले पाओ के आधार पर एक जिले से केवल 03 प्रतिभागियों को शामिल करेगा। कार्यक्रम में केवल वे प्रतिभागी ही भाग ले सकेंगे जिनकी प्रतिभागिता की पुष्टि संस्थान द्वारा कर दी गई हो। आपसे अनुरोध है कि नामित प्रतिभागियों द्वारा पूर्णतः भरे हुए नामांकन प्रपत्र, प्रायोजन पत्र के साथ भेजें। नामांकन प्रपत्रों के बिना प्राप्त प्रायोजन पत्रों पर विचार नहीं किया जाएगा।

## AIM

The programme aims to equip the participants with knowledge and skills for effective Prevention, Identification, rescue, release and immediate rehabilitation of Bonded Labour and Child Labour

## OBJECTIVES

- To enhance understanding of the issues of Bonded Labour and Child Labour
- To strengthen skills for Identification of Bonded Labour and Child Labour
- To impart knowledge on Standard Operating Procedures (SOPs) for Identification and Rescue of Bonded Labour
- To understand the linkage between climate change, distress migration, Human Trafficking, Bonded Labour and Child Labour
- To discuss the importance of effective and timely rehabilitation during the Critical Crisis Period after a bonded labour/child labour is rescued

## COURSE PROFILE

BLSA Act (1976), CALPR Act, IPC 370, Standard Operating Procedures on Bonded Labour and Child Labour (MoLE), Bonded Labour Rehabilitation Scheme (MOLE 2016), Supreme Court Judgements, NHRC Guidelines & Role of Statutory and Law Enforcement bodies (Police, Labour Department, Vigilance Committees, District Magistrates, and others)

## METHODOLOGY

Sessions will include interactive discussions, case study presentations, sharing of best practices, group discussions, video/audio presentations, and follow-up field activities

Trade Unions, Civil Society Organizations, elected Representatives of Panchayati Raj Institutions (PRIs), and Child Line.

The Institute Campus is situated in Sector – 24 near PRAKASH Hospital and NTPC Ltd. and is at a distance of 20 KMs. from the New Delhi Railway Station. **For extended stay or early arrival, the charges would be borne by the participants.** NOIDA is situated at Delhi border in close proximity to Mayur Vihar, Delhi.

## ELIGIBILITY

1. Participants should be above **22 years and below 50 years of age**
2. Should be personally engaged at grass roots level activities for at least past two years;
3. Should be fluent in either Hindi or English.

### Note:

1. **Spouse/family members/relatives are not allowed to stay in the Institute's Hostel.**
2. **Participants are requested to book their return ticket in advance from their own place.**

## STAY ARRANGEMENTS

Stay arrangement will be made at the Hostel of V.V. Giri National Labour Institute. **The accommodation will be on twin sharing basis.** Boarding and lodging will be provided by the Institute for the participants only from the afternoon of April 25, 2022 to the forenoon of April 29, 2022. **For extended stay or early arrival, lodging & boarding charges would be borne by the participants.**

## TRAVELLING EXPENSES

1. No fee is charged from the participants.
2. The Institute would reimburse travel expenses of the participants for 2nd class sleeper Train/Bus fare from their place of work to NOIDA on **production of ORIGINAL ticket for inward journey and for return journey, a photo copy of CONFIRMED ticket should be produced to claim reimbursement.** Without submission of tickets, no reimbursement claim will be permissible. The Nominees should be informed about the reimbursement procedure accordingly to avoid inconveniences.
3. It may be ensured that nominee(s) should have Aadhar number. The nominations of only those participants will be accepted who have Aadhar number and Bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. All the nominees may be informed accordingly.
4. The local conveyance will be reimbursed restricted to the actual expenditure incurred or Rs. 500/- whichever is less (Rs. 350/- for Delhi & NCR).
5. **The participants are provided boarding and lodging at free of cost only for the duration of the programme.**
