

Contract for empanelment of the agencies for hiring of taxis

Scope of work

The scope of work shall be providing of Taxis on hiring basis for meeting of official work in Noida/Greater Noida/Delhi and outside Delhi.

Terms & Conditions

1. The agency should have registered with the transport department (enclose copy).
The agency which is not registered with the transport department will not be considered for empanelment.
2. The agencies will undertake to provide:
 - (a) The drivers should have more than 3 years driving experience and valid driving license.
 - (b) Drivers in uniform.
 - (c) Not more than 10 years old vehicles.
 - (d) Vehicles with valid fitness certificates.
 - (e) Vehicles with valid comprehensive Insurance.
 - (f) Vehicles with valid pollution check certificate.
3. The agencies are also required to give the following details:-
 - (a) List of clients during last 3 years
 - (b) Number of Vehicles with ownership details
 - (c) Whether drivers know all Delhi & NCR routes
 - (d) Any other information.
 - (e) The agency should submit a certificate stating that their agency has not been blacklisted by any Govt. Deptt./PSUs/any other organizations.
4. The payment to the agency for Hiring of Taxis will be made fortnightly.
5. TDS as per rule will be deducted from the bills.
6. The Institute will pay GST / any other tax at the prescribed rates from time to time for which the agency should submit GST number allotted to them alongwith supporting documents.



7. The agency shall have to comply with all the relevant labour laws and other laws as applicable.
8. The drivers should be educated, good moral character and have never been convicted for a criminal offence by a Court of Law. The PVRs of drivers should be provided by the transporter.
9. The Taxis should be provided in the Institute or any other place so specified well in time. Non providing of Taxis well in time will lead to imposing of suitable penalty.
10. The transporters will be empanelled at the rates fixed by the Institute on the basis of the lowest rates received.
11. Validity of the tender
 - a. The validity of the tender will be initially for a period of one year which can be extended further on year to year basis but the maximum period will not be exceeded more than three years.
 - b. The rates agreed upon shall remain same throughout the period of empanelment.
12. The circumstances in which accepted rates can be enhanced.
 - a. During the first year of the initial three years of the contract period, no enhancement would be allowed on account of any reason, whatsoever, including increase in the fuel prices during this period.
 - b. However, in the second year of the initial three year's contract period, if the fuel prices increase by more than 10%, (taking fuel prices prevailing as on the date of signing of the Agreement as the base, and the fuel rates prevailing as on last day of the completion of one year from the date of signing of the Agreement), accepted rates for the second/third year would be enhanced as per following table.

For fuel charges increase, percentage enhancement which can be allowed in agreed rates.
13. The Agency has to provide a certificate with regard to GST number, PAN number issued by competent authority (attach photocopy).



Upto 10%	No enhancement
Beyond 10%	<p>i) $\frac{1}{3}^{\text{rd}}$ of percentage by which fuel charge increased e.g. if fuel charges during the 1st year have increased by 40%, the agreed rates would be enhanced by 10% $(40-10)/3$.</p> <p>ii) If fuel charge have increased by 70%, agreed rates would be increased by 20% $(70-10)/3$.</p>

- **EMD:** The tenderer submitting their quotations for Taxis should submit a Demand Draft in favour of V.V Giri National Labour Institute, Noida of Rs.5000/- as EMD.
- **Performance Security deposit:** On Empanelment, the agency should deposit an amount of Rs.15000/- as Performance Security Deposit which will be returned after completion of the contract.
- The agencies should clearly indicate:
 - (a) Charges for extra hours
 - (b) Charges of extra Kms.
 - (c) Night charges (Mention Time)
 - (d) GST
 - (e) Any other charges.
