We are pleased to inform you that the V.V. Giri National Labour Institute would be organising a Training Programme on "Future of Work - Ensuring Decent Work and Social Protection for Gig Workers" from November 25-27, 2024, at VVGNLI Campus NOIDA.

This training programme aims at enhancing the understanding of the participants on the growing diversification of work arrangements and the transformations in the labour market due to automation and digitalization. As the world of work continues to evolve, some emerging work and employment arrangements may provide greater flexibility for workers and employers, but they may lead to significant gaps in social protection coverage. It is therefore necessary to strengthen and adapt social protection systems to a changing world of work. More than ever, they have a key role in preventing poverty, reducing inequality, enhancing income security and enabling workers and their families to better navigate work and life transitions.

There is no programme fee. The Institute will provide free of charge boarding and lodging facility to the participants during training period. This training programme specially designed for the Officials from the Central and State Labour Departments, senior leaders of central trade unions and representatives of Gig Workers Unions. The participants should be below 60 years of age with at least five years of work experience and knowledge of both English and Hindi. The institute will reimburse second class sleeper train fare only to the participants.

सहर्ष सूचित किया जाता है कि वी .वी .गिरि राष्ट्रीय श्रम संस्थान में 'कार्य का भविष्य- गिग श्रमिकों के लिए सभ्य कार्य और सामाजिक सुरक्षा सुनिश्चित करना' पर 25-27 नवंबर, 2024 के दौरान प्रशिक्षण कार्यक्रम का आयोजन किया रहा है।

इस प्रशिक्षण कार्यक्रम का उद्देश्य स्वचालन और डिजिटलीकरण के कारण कार्य व्यवस्थाओं के बढ़ते विविधीकरण और श्रम बाजार में परिवर्तनों पर प्रतिभागियों की समझ को बढ़ाना है। जैसे-जैसे काम की दुनिया विकिसत हो रही है, कुछ उभरती हुई कार्य और रोजगार व्यवस्थाएं श्रमिकों और नियोक्ताओं के लिए अधिक लचीलापन प्रदान कर सकती हैं, लेकिन वे सामाजिक सुरक्षा कवरेज में महत्वपूर्ण अंतराल पैदा कर सकती हैं। इसलिए काम की बदलती दुनिया के लिए सामाजिक सुरक्षा प्रणालियों को मजबूत करना और अनुकूलित करना आवश्यक है। पहले से कहीं अधिक, गरीबी को रोकने, असमानता को कम करने, आय सुरक्षा बढ़ाने और श्रमिकों और उनके परिवारों को काम और जीवन में बेहतर बदलाव के लिए सक्षम बनाने में उनकी महत्वपूर्ण भूमिका है।

कार्यक्रम के लिए कोई शुल्क नहीं है। संस्थान प्रशिक्षण अवधि के दौरान प्रतिभागियों को निःशुल्क आवास और भोजन की सुविधा प्रदान करेगा। यह प्रशिक्षण कार्यक्रम विशेष रूप से केंद्रीय और राज्य श्रम विभागों के अधिकारियों, केंद्रीय ट्रेड यूनियनों के वरिष्ठ नेताओं और गिग वर्कर्स यूनियनों के प्रतिनिधियों के लिए डिज़ाइन किया गया है। प्रतिभागियों की आयु 60 वर्ष से कम होनी चाहिए और उन्हें कम से कम पाँच वर्ष का कार्य अनुभव और अंग्रेजी और हिंदी दोनों का ज्ञान होना चाहिए। संस्थान प्रतिभागियों को केवल द्वितीय श्रेणी स्लीपर ट्रेन का किराया वापस करेगा।
