The programme aims at enhancing the understanding of the participants on the process of labour reforms in India. It would orient the participants to have an understanding on the key features of various labour codes.

OBJECTIVES

- To discuss the overall framework of labour legislation in India and the context of labour law reforms
- To provide an overview of the constitutional framework for formulation of labour legislation
- To discuss the key features of four labour codes in India
- To understand the implication of these codes on the labour market.

COURSE PROFILE
