This training programme has been designed for Government Officials, Union Leaders from Central Trade Unions, Researchers from University and research institutions, Civil Society representatives, employers representatives, Gig and Platform Workers etc. The programme aims to understand the rapid changes in the world of work due to digital transformation and technological advancements leading to rise in new forms of employment. The programme will be conducted in English and Hindi.

There is no programme fee. The Institute would provide free boarding and lodging facility. यह प्रशिक्षण कार्यक्रम सरकारी अधिकारियों, केंद्रीय ट्रेड यूनियनों के यूनियन नेताओं, विश्वविद्यालय और शोध संस्थानों के शोधकर्ताओं, सिविल सोसाइटी के प्रतिनिधियों, नियोक्ता प्रतिनिधियों, गिग और प्लेटफ़ॉर्म वर्कर्स आदि के लिए डिज़ाइन किया गया है। कार्यक्रम का उद्देश्य डिजिटल परिवर्तन और तकनीकी प्रगति के कारण काम की दुनिया में तेजी से हो रहे बदलावों को समझना है, जिससे रोज़गार के नए रूपों में वृद्धि हो रही है। यह श्रम बाजारों में लैंगिक अंतर की समझ विकसित करने, डिजिटल बहिष्कार/समावेश के मुद्दों और भविष्य के कार्य परिदृश्य में महिलाओं के रोजगार को बढ़ावा देने पर भी ध्यान केंद्रित करता है। कार्यक्रम अंग्रेजी और हिंदी में आयोजित किया जाएगा।

#### AIM

The programme aims to understand the rapid changes in the world of work due to digital transformation and technological advancements leading to rise in new forms of employment. It also focusses on developing an understanding of gender gaps in the labour markets, issues of digital exclusion/inclusion and promoting women's employment in the future of work scenario.

#### OBJECTIVES:

- Provide an overview of transitions in the context of the future of work and the impact of technology on women in workplaces.
- To understand about new and emerging forms of employment for women in the gig and platform economy.
- To understand about the skilling/ up skilling/ reskilling opportunities (including Science Technology Engineering and Mathematics, STEM fields) for women in the workplace and identify skills in the future of work to help women transition into new jobs.
- To provide an overview of key reform measures including legislation and policy framework to promote gender equality and digital inclusion in the future of work.

- 1. Participants should be above 21 years and below 60 years of age;
- 2. Should be personally engaged at grass root level activities for at least past two years;
- 3. Should be fluent in either Hindi or English.

- 2. Spouse and family members are not allowed to stay in the Institute's hostel.

#### STAY ARRANGEMENT

Stay arrangement will be made in the hostel of V.V. Giri National Labour Institute. The boarding and lodging will be provided by the Institute from the afternoon of February 02, 2025 till the forenoon of February 08, 2025. Accommodation will be on twinsharing basis. For extended stay or early arrival, lodging & boarding charges would be borne by the participants.

#### TRAVELLING EXPENSES

- 1. No fee is charged from the participants.
- 2. The Institute would reimburse travel expenses of the participants for 2nd class sleeper Train/Bus fare from their place of work to NOIDA on production of ORIGINAL ticket for inward journey and for return journey, a photo copy of CONFIRMED ticket should be produced to claim reimbursement. Without submission of tickets, no reimbursement claim will be permissible. The nominees should be informed about the reimbursement procedure accordingly to avoid inconveniences.
- 3. It may be ensured that nominee(s) should have Aadhar number. The nominations of only those participants will be accepted who have Aadhar number and bank account. The reimbursement of travel fare to the nominees would be made through NEFT only. The nominee(s) may be informed to bring their bank details (name of bank, name of bank branch, IFSC code and bank account no.) with them. The bank details may be indicated by nominee while filling up TA form at the institute. All the nominees may be informed accordingly.
